In addition to Public Service Announcements aired in support of National, Regional and Local Organizations and Programs, our programming contains special programs devoted to our community's businesses and organizations. The following lists and describes these special programs.

LOCAL NEWS: Aired twice a day at 7:00 AM and 12:00 PM. LENGTH OF NEWSCAST IS 5 MINUTES. News items included relate to local and area events of interest in this community.

EMERGENCY WEATHER ANNOUNCEMENTS: Pending or current emergency weather announcements are given in order to warn or update regional listeners. This includes but is not limited to; road conditions, school and public/county office closings or postponements; energy utility outages; meeting postponements. Often, law enforcement personnel will call in. KVRE is the go to station for current weather conditions.

GOLF REPORT: Aired at 7:31 AM. LENGTH OF GOLF REPORT IS TWO MINUTES. This gives the local golf course's tee times, conditions, latest noteworthy activities and upcoming special events.

COMMUNITY CALENDAR: This lists local church and organization activities. The need is so great for this type of programming that it airs FIVE times a day, MONDAY THROUGH FRIDAY; and FOUR times a day SATURDAY & SUNDAY every week with a length of THREE minutes each.

TAKE 5: This special program was created solely to allow a more in-depth interview with key personnel in local business and organizations, thereby allowing the community to have a greater awareness of organizations and new businesses in their area. It features a 5 minute interview daily or sometimes a 15 or 20 minute interview is divided into several segments and aired on successive days. The need for more than one program in a day is often the case.

ASK YOUR NEIGHBOR: An hour open to calls on local and toll-free phone lines, Monday through Friday 10:07am-11am, a 53 minute program. Hosted by Tom Nichols, political and medical problems or opinions are not allowed and no for sale for monies notifications. The main purpose of the program is for the listening audience to request information or exchange information on items they need, recipes, help with lawn/household problems; recommendations of local services, etc... Nichols has a loyal and regular listening audience and will occasionally frequent a LIVE interview with a known celebrity or politician.

TORNADO RELIEF-KVRE RADIO

On March 31, 2023, devastating tornados ripped through Central and eastern Arkansas. Hot Springs Village was spared any destruction, but that was not the case for our neighbors east of us. Sitting in my office watching the path and seeing Little Rock take a direct path, I knew our station needed to help. That night, I texted our Director of Arkansas Broadcaster's Luke Story to see first and foremost if he was okay and if his wife Sarah and their kids were okay. After learning they were okay, I told Luke that I needed to do something to help. I wrote a promo that Friday night and sent it to Luke. I started the promo on KVRE first thing Saturday April 1st and starting that Monday April 3rd we started collecting non-perishable and personal hygiene items at my office. My entire staff knew this was the mission and we devoted every LIVE show and numerous Facebook Video's and post to collecting these items. My entire goal was for my Morning man Tracy Simpson to have to hook up his trailer and my listeners did not disappoint. Every day for a week, my office had a constant stream of people coming in to drop off items and some people even dropped off monetary donations. Tracy got 76 cases of water donated, so we absolutely met our goal, and the trailer was filled. On Tuesday April 11th, we loaded up Tracy's backseat, bed of his truck and the trailer and headed to Little Rock. We met Luke on Shackleford and saw the destruction firsthand. It was completely humbling, and I was so thankful that I had the platform to help. We followed Luke to the donation center off Shackleford and dropped off all the items collected. 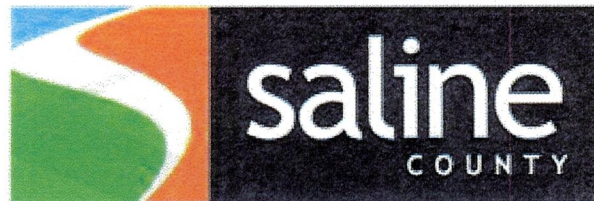

Saline County Severe Weather Alert Systems

Saline County, AR – With severe weather conditions in the forecast for late tonight, April 4 and early tomorrow morning, April 5, Saline County would like to remind residents of existing alert systems across the county. In the instance a Tornado Warning is issued for any portion of Saline County, the County has the ability to inform and warn residents through mandatory messages from the National Weather Service, Everbridge, Tornado Sirens and Social Media Channels.

When the National Weather Service (NWS) issues a Tornado Warning, they use the FEMA Integrated Public Alert and Warning System (IPAWS) to send mandatory messages to phones located within that Warning area. These alerts are extremely useful in providing timely warning to take shelter, so we recommend that all residents keep their phones charged and nearby. Individual responsibility and preparedness are crucial to the electronic warning methods using your phones. You do not have to sign up in order to receive IPAWS messages from the NWS.

Saline County residents also have the opportunity to sign-up for emergency alerts through Everbridge. Residents have the ability to receive texts, emails, and/or phonecalls through the Everbridge system whenever a watch or warning is issued for Saline County. Residents can sign-up for alerts by going to salinecounty.org/emergency_management and clicking on the "Everbridge-Emergency Notifications Tab". Residents must first create an account with Everbridge before receiving alerts.

In addition, Saline County has 45 Tornado Sirens across the county. These sirens are divided into six different warning activation zones throughout the county. When a Tornado Warning is issued from the National Weather Service, Saline County's OEM (Office of Emergency Management) will ONLY activate sirens in the zone where the warning is located and zones in the path of the warning. Saline County does NOT activate all countywide sirens at the same time. Because of their limited reach, tornado sirens are primarily placed in areas of public gathering.

"Saline County has one of the most advanced warning systems across the state of Arkansas, and we use a layered defense to help send warnings to our citizens. Our staff remains on duty during severe weather in order to provide timely warnings to those in the danger path", said Brandon Guillot Saline County Office of Emergency Management Director.

Finally, Saline County residents are also encouraged to follow and check the County and OEM's Social Media pages on Facebook and Twitter during a severe weather event. Residents can follow OEM on Facebook: @SalineCountyOEM and Saline County on Facebook: @SalineCounty and Twitter:@SalineCountyAR. The issuance and cancellation of watches and warnings will be communicated through these social media accounts.

"Staying up to date with the most current information during an emergency situation is of the utmost importance. Saline County is dedicated to providing this information to our citizens and we encourage our citizens to have a plan of action at home and work", said Saline County Judge Matt Brumley.

If you are in the path of a Tornado Warning, the National Weather Service does not recommend traveling to another structure. Instead, shelter in place using the innermost room of your home away from exterior walls or windows.

St. Francis House in Little Rock is a 501-C3 that helps those less fortunate in the community and helps Veteran's that are either re-acclimating to civilian life or unfortunately our Veteran's that are homeless. Every year for the last several year's my Morning Man Tracy Simpson has been doing a collection coat drive for St. Francis House. When we delivered coat's that we had collected through November 2022 in December, the executive Director of St. Francis House Greg Chastise asked us if we would be interested in doing a drive in the spring for clothing items and personal hygiene items. We said absolutely and had planned on starting toward the end of March as people were doing spring cleaning. Then the tornado's happened in our state and we did the Tornado Relief Drive for the residents of our state that had lost everything. Tracy and I met, and we decided to do the drive for St. Francis House in the month of May and tie it into Memorial Day and what the true meaning of Memorial Day is all about. If it weren't for the scarifies of our Veteran's, we wouldn't be able to do what we do today. We collected at the studios of KVRE all month and once again our listeners did not disappoint, and we had to hook up Tracy's trailer to load everything and deliver to St. Francis House. On Monday June 5th, Tracy and I delivered everything, and we told Greg we would see him in December after we do the fall coat drive!
